




ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 9 – No. 7 LLOYD WRIGHT raced without trotting hobbles after qualifying without them on October 8. The horse was programmed with them in error.

Inquiry posted on unofficial third place finisher No. 1 SOME KINDA NIGHT (Trace Tetrick) for possible violation of the pylon rule in the far turn before 3/4s. Video showed the horse running over one pylon and inside of another. The judges determined that this did not give the horse an unfair advantage. No. 1 SOME KINDA KNIGHT placed as finished.
