## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 – With the scratch of No. 2 PARKLANE HILL reducing the field to five betting interests superfecta wagering on the race cancelled per IHRC wagering rules.

Race 6 – Inquiry posted on unofficial fourth place finisher No. 8 DOUBLE CLASS (Marvin Luna) for possible violation of the breaking rule before the quarter. The judges determined that Mr. Luna complied with all aspects of the breaking rule and there was no reason for placing.

Race 11 – Inquiry posted on unofficial fourth place finisher No. 10 WORTH YOUR WHILE (Marvin Luna) for possible violation of the breaking rule in the stretch. Video showed that while off stride the horse failed to lose ground and was gaining on the horses in front of him. For violation of the breaking rule, failure to lose ground while on a break, No. 10 WORTH YOUR WHILE finished fourth placed seventh.
