ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiry posted on unofficial third place finisher No. 2 MARSHALL ZHUKOV (Atlee Bender) for possible pylon violation in the stretch. Video showed that Mr. Bender was possible inside of one pylon and may have even struck it. Regardless, the judges determined that this action did not give the horse an unfair advantage as no other horses in the field were passed. No reason to disqualify the horse and No. 2 MARSHALL ZHUKOV was placed as finished.

Race 14 - Dan Shetler, driver of No. 5 ROCKIN MY HEART, fined \$100.00 for crossing over before the start.
