Race 5 – Kiwon Waldron, driver of No. 6 TROTEN AWAY, fined \$100.00 for abruptly turning his horse after the finish of the

Race 8 - Inquiry posted on unofficial second place finisher No. 5 TRAGEDY (Marcus Miller) for possible pylon violation after 3/4s entering the stretch. After reviewing video the judges determined that the horse was inside of one pylon and struck a second without gaining an unfair advantage. Horse placed as finished.

Race 10 – Inquiry posted on unofficial fourth place finisher No. 8 MIZ CAPTAIN CRUZE (Kyle Wilfong) for possible violation of the breaking rule after the start and entering the first turn before the quarter. After reviewing video the judges determined that Mr. Wilfong complied with all aspects of the breaking rule and the horse was placed as finished.
