Race 2 - Inquiry posted on unofficial third place finisher No. 6 BIG SWIG (Kyle Wilfong) for possible violation of the breaking rule past 3/4s at the top of the stretch. Video showed that driver Wilfong complied with all aspects of the breaking rule and there was no reason for disqualification. Horse placed as finished.

Race 8 - Inquiry posted on unofficial fourth place finisher No. 2 FLORIDA (Atlee Bender) for possible pylon violation in the far turn just past 3/4s. Video showed that Mr. Bender's tire struck multiple pylons, but did not go inside of any. No violation and the horse was placed as finished.

No. 6 ONE TRIP CHIP (Mike Oosting) originally finished seventh placed eighth for violation of the breaking rule in the stretch (extended break).

Race 11 – Inquiry posted on unofficial fourth place finisher No. 3 CLAPTON (Atlee Bender) for possible violation of the breaking rule in the stretch. Video showed the horse make a break in the stretch and while off stride caused interference to all but the two horses that were ahead of him at that point in the race. For interference to trailing horses while on a break, No. 3 CLAPTON finished third placed ninth.
