ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 7 – Inquiry posted on unofficial fifth place finisher No. 9 BE COOL OLD FOOL (Jared Finn) for possible violation of the breaking rule in the stretch. Video showed the horse make a break mid-stretch and remain off stride through the finish. The judges determined that driver Finn failed to continuously lose ground while on a break. Due to the proximity of trailing horses at the wire, No. 9 BE COOL OLD FOOL finished fifth place ninth for violation of the breaking rule.

Close to a 20-minute tote delay due to "links" being down in the betting network. This same problem occurred last week causing a much shorter delay.
