Race 1 – General inquiry looking at two breaking horses. No. 3 DIGITAL SOLIDER (James Yoder) made a break in the far turn before and after 3/4s. No. 6 PETE THE FREAK (Marcus Miller) made a break in mid-stretch. After reviewing video the judges determined that both drivers complied with the breaking rule. No. 3 DIGITAL SOLDIER finished fifth and PETE THE FREAK finished third. Both horses placed as finished.

Race 4 – Superfecta wagering on the race cancelled as the field scratched down to five betting interests.




Race 5 – No. 4 DREAMS COME EASY (Trace Tetrick) finished sixth placed seventh for violation of the breaking rule; lapped on break).
