No. 10 WATCH MISS TUCKY originally finished eighth placed ninth for violation of the breaking rule in the stretch.

Race 9 - No. 4 VEL OVER YONDER originally finished sixth placed ninth for interference to trailing horses while on a break in the stretch.

Race 13 - No .5 TELLME UR MYDATE was gelding. Announcements made via TV scroll and track announcer.
