Race 6 - No. 6 FOX VALLEY JASPER was scratched due to sickness reducing the field to five betting interests. Per IHRC wagering rules, superfecta wagering on the race was cancelled. Also due to IHRC claiming rules the claim filed on this horse was void.

Race 9 - Inquiry posted on unofficial fourth place finisher No. 6 GOLDEN TACTIC (Jared Finn) for possible violation of the breaking rule before 3/4s. After reviewing video the judges determined that driver Finn complied with all aspects of the breaking rule and the horse was placed as finished.
