ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - Trainer correction allowed in a claiming race due to race office error. No. 4 SHANGHAI BOBBY listed trainer was Alicia Binkley, correct trainer is Clint Binkley.

Race 6 – No. 8 DRAMA CRITIC (Marvin Luna) originally finished seventh placed ninth for an extended break in the stretch.

Race 7 – Inquiry posted on unofficial race winner No. 8 CANTHAVEME (Brandon Bates) for possible interference to unofficial seventh place finisher No. 6 FREE CLIMB (LeWayne Miller) in the stretch. After reviewing video and speaking with driver LeWayne Miller the judges determined that No. 8 CANTHAVEME moved off the rail out into the path of No. 6 FREE CLIMB causing driver Miller to change course to avoid being struck. For interference No. 8 CANTHAVEME finished first placed seventh. Driver Bates fined \$200.00 for interference causing a placing.

Race 11 – Inquiry posted on unofficial third place finisher No. 2 JDS CHANCEY ALLIE (Jordan Ross) for possible pylon violation entering the top of the stretch. Video showed that Ross' wheel was inside two pylons, however the horse was not lapped on at the finish and the judges determined that this did not give the horse an unfair advantage. Horse placed as finished, Jordan Ross fined \$100.00 for a pylon violation with no placing.

Race 14 – Inquiry posted on unofficial fourth place finisher No. 7 SERIOUSLY FEARED (AJ Wright) for possible pylon violation before $\frac{3}{4}$. Video showed that the horse was inside two pylons, out, then inside one more pylon farther in the turn. The judges determined that this did not give the horse an unfair advantage. No reason for placing. Driver AJ Wright fined \$100.00 for a pylon violation with no placing.
