




### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 - No. 2 DONTSPANKCHECKY (Joey Putnam) originally finished seventh placed eighth for violation of the breaking rule after the half (interference to trailing horses while on a break).

Race 11 - Inquiry posted on unofficial second place finisher No. 7 FOX VALLEY SILENT (Mike Oosting) for possible interference to trailing horses while on a break before 3/4s. Video confirmed FOX VALLEY SILENT was still on a break when driver Oosting took the horse to the outside and in so doing caused interference to No. 4 DIGITAL SOLDIER (James Yoder) causing that horse to make a break. For interference to trailing horses while on a break No. 7 FOX VALLEY SILENT finished second placed ninth. No penalty to driver Oosting. DIGITAL SOLDIER charted with an interference break thus keeping the horse off the list for repeated breaks.
