ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiry posted on unofficial third place finisher No. 8 LILLIPUTIAN (Trace Tetrick) for possible violation of the breaking rule in the far turn before ¾. After reviewing video the judges determined that the horse was off stride briefly and that driver Tetrick complied with all aspects of the breaking rule. No. violation and the horse was placed was finished

Race 7 – No. 7 LOUNAR ECLIPSE (Ricky Macomber, Jr.) originally finished ninth placed tenth for a lapped on break.

Race 13 – Inquiry posted on unofficial fourth place finisher No. 5 VEL LITTLE BLISTER (Mike Peterson) for possible interference to unofficial eighth place finisher No. 6 ODDS ON FREEROLL (Marvin Luna) in the far turn approaching ¾. After reviewing video and speaking to driver Luna the judges determined that the horse broke on its own and there was no reason for placing.
