ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – No. 3 VALEDICTORIAN (Marvin Luna) originally finished fifth placed seventh foe violation of the breaking rule in the stretch; failure to lose ground while on a break.

Race 12 – Inquiry posted on unofficial race winner No. 7 TOYS FOR YOU (Rick Plano) for possible interference to unofficial fourth place finisher No. 2 JUSMAKINYALOOK (Jordan Ross) and unofficial fifth place finisher No. 6 TUG AND COOP (Atlee Bender) in the stretch. After reviewing video of the incident and speaking with driver Ross the judges were able to determine that Mr. Plano changed course in the stretch striking the legs of Mr. Ross' horse at least twice also forcing that horse into the path of No. 6 TUG AN COOP. For interference to trailing horses No. 7 TOY'S FOR YOU finished first placed fifth. Driver Plano fined \$200.00 for interference causing a placing.
