## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – No. 3 TROUBLE SHOOTER (Mike Oosting) originally finished sixth place seventh for interference to trailing horses while on a break in the far turn before 34.

Race 6 - Inquiry posted on unofficial race winner No. 4 GORGEOUS BIG GUY (John DeLong) for possible interference to unofficial fifth place finisher No. 3 PLAY ACTION PASS (Brandon Bates) and unofficial fourth place finisher No. 5 PONDA WARRIROR (Kyle Wilfong) in the stretch. After reviewing video and speaking with both drivers Wilfong and Bates the judges determined that No. 4 GORGEOUS BIG GUY interfered with No. 5 PONDA WARRIOR forcing that one to change course in turn causing interference to No. 3 PLAY ACTION PASS. For causing interference to both No. 3 PLAY ACTION PASS and No. 5 PONDA WARRIOR, No. 4 GORGEOUS BIG GUY finished first placed fifth. Driver DeLong fined \$200.00.

Race 13 – Driver Sam Widger fined \$100.00 for failure to drive when programmed necessitating a late driver change. Horses sent back to the paddock to allow No. 10 AWESOME BEACH to change out his harness after the original broke.
