
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 2 - Inquiry posted on unofficial fourth place finisher No. 10 ROCKIN DAWG (Anthony Miller) for possible interference to unofficial sixth place finisher No. 2 BEAUMOND HANOVER (Brandon Bates) at the top of the stretch. Mr. Bates contended that Mr. Miller's horse came out into his path forcing him to move over which is shown on the video (head-on shot) as well. For interference in the stretch No. 10 ROCKIN DAWG finished fourth placed sixth. Driver Anthony Miller fined \$200.00 for interference causing a placing.


Race 6 - Juan Franco, listed driver of No. 1 SLEAZYANDINCHARGE, fined \$100.00 for failure to drive when programmed.

Race 7 - Pat Melloy, Jr., trainer of No. 7 FOLSOM PRISON, fined \$100.00 for making a late driver change after scratch time.

Race 8 - No. 6 DAPPER DESIGN was gelded. Announcements made via TV scroll and track announcer.
