Race 3 – Inquiry posted on unofficial fourth place finisher No. 9 BETROTHED (Brandon Bates) for possible interference to unofficial eighth place finisher No. 8 OUR MONEY HEIST (Marcus Miller) while on a break going to the half. After reviewing video and speaking with driver Miller the judges determined that No. 9 BETROTHED did interfere with No. 8 OUR MONEY HEIST. For this violation No. 9 BETROTHED finished fourth placed eighth. No penalty to driver Bates.

Race 4 - No. 4 GENERAL GRANT was a late vet scratch due to lameness.

Race 5 - No. 1 LETSGOTOTHEMOON was first time Lasix.

Recall charged to No. 2 ER BETHANY due to broken equipment.

Inquiry posted on unofficial fourth place finisher No. 3 WELL DRESSED MAN (James Yoder) for possible violation of the breaking rule before the start. After reviewing video the judges determined there was no violation of the breaking rule.

Race 10 – No. 9 LUCKYSTAIR (Mike Peterson) finished fifth placed seventh for a pylon violation before 34. Driver Mike Peterson fined \$200.00 for a pylon violation causing a placing.

Race 11 – No. 1 TUCKY GIRL was a late vet scratch due to lameness. The horse was placed on the vet's list and must qualify. Inquiry posted on unofficial third place finisher No. 3 SCORECARD DAN (Mike Oosting) for possible violation of the breaking rule going up the backstretch past the ¼. After reviewing video the judges determined there was no reason to place the horse as driver Oosting complied with the breaking rule.
