ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Amy Husted, trainer of No. 2 PEACE STAR, fined \$100.00, for failing to have a licensee with the horse for pre-race blood gas testing.

Race 4 – No. 3 PASSIN WITH A SIGH (John DeLong) originally finished fifth placed sixth for interference to trailing horses while on a break before 3/4s. No penalty to driver DeLong.

Inquiry posted on unofficial fourth place finisher No. 6 ONE MIKE OUT (Clint Coy) for possible violation of the breaking rule in the stretch. After reviewing the break the judges determined that driver Coy fully complied with the breaking rule and the horse was placed as finished.

Wyatt Avenatti, driver of No. 7 UNHYNGED CADEAU, fined \$100.00 for failure to set an maintain a proper pace in the second quarter of the mile.

Race 6 - The scratch of No. 1 DOVER IN MOTION reduced the field to five betting interests. Per IHRC rules superfecta wagering on the race was cancelled.

Race 7 - Purse correction from \$7,000 to \$8,050 as the race was all Indiana-sired.
No. 7 PONDA STRIPES (Kyle Wilfong) originally finished ninth placed tenth for an extended break in the stretch.


Race 11 - Atlee Bender, driver of No. 10 HOT MARTINI, fined \$100.00 by starter Todd Nixon for failure to come up into position.
