Race 9 - Trainer James Molitor fined \$200.00 for failure to honor declaration of the horse No. 3 LEADER OF THE BAND.

Race 13 - No. 8 POINTS NORTH was a late vet scratch after tying-up in the paddock.

Race 14 - No. 6 CHESAPEAKE THUNDER (Atlee Bender) originally finished sixth placed ninth for violation of the breaking rule while in the stretch (failure to continuously lose ground while on a break).
