


ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 9 - Inquiry posted on unofficial second place finisher No. 7 VEL SEE YOU LATER (Clint Coy) for possible violation of the breaking rule in deep stretch nearing the finish. Video confirmed that the horse was off stride through the wire and lapped on by another horse. For violation of the breaking rule (lapped on break) No. 7 VEL SEE YOU LATER finished second placed third.

Race 10 - General inquiry concerning the start and No. 1 FASHION BABY (Cordarius Stewart) possible interference to No. 10 WINKYS WOW (Jordan Ross) while on a break. After reviewing video the judges determined that the No. 1 breaking stride did not cause interference to No. 10 WINKYS WOW. No. 10 WINKYS WOW considered a starter for wagering purposes.
