### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 2** – No. 3 KING OF CASH (Jordan Ross) finished fifth placed sixth for violation of the breaking rule; lapped on break.

**Race 6** - Trace Tetrick, driver of No. 6 ANGEL HILL, fined \$100.00 for failure to drive when programmed.

**Race 11** – Joey Putnam, driver of No. 8 YOU FOUND OUT, fined \$100.00 for failure to drive when programmed.

No. 6 UNCLE ARCHIE was programmed without trotting hobbles in violation of IHRC rules as the horse had been racing with them and did not qualify to take them off. Trainer Matthew Miller fined \$100.00 for failure to have the horse properly equipped.

No. 7 KING FURY was a late vet scratch due to lameness.




**Race 12** – No. 2 EVER A JK was a late vet scratch after tying-up in the paddock. With the scratch the field was reduced to five betting interests. Per IHRC wagering rules superfecta wagering on the race was cancelled.

**Race 13** – Objection/inquiry posted on unofficial third place finisher No. 4 ANDOVERTHEWINNINGS (Kyle Husted) for possible interference to No. 1 DASH OF LUCK (Marvin Luna0 after the start. While video showed that No. 4 struck the No. 1's tire, the judges determined that the No. 1 drifted out into the path of the No. 4 and was the cause of any issues. No reason for disqualification. No. 1 DASH OF LUCK charted with "be" after the start.
