## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 – Jeff Dever, driver of No. 4 KITALPHA, fined \$100.00 for failure to set and maintain a proper pace.

Race 5 – No. 2 YA CAUGHT, trained by Luis Quevedo, was sent for postrace blood gas testing after missing prerace. Mr. Quevedo was given a warning and told the next time it happens his horse would be scratched and he would be issued a fine.

Race 7 – Inquiry posted on unofficial third place finisher No. 4 SEVEN LICK TOM (Atlee Bender) for possible interference to unofficial ninth place finisher No. 1 VALEDICTORAIN (Don Eash) in the far turn approaching 3/4s. While the video was inconclusive at best, driver Eash testified that his filly "got excited" with other horses in front of her and that Mr. Bender did not cause interference. No changes and the horses were placed as originally finished.
