ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 5 – Driver change on NO. 7 VEL WHAT A LONGSHOT from Jordan Ross to Mike Peterson. Mr. Ross owned part of No. 3 FASHIONABLY LATE and could not drive against a horse he owned.

Race 9 – Inquiry posted on unofficial fourth place finisher No. 1 MONACO (Robert Taylor) for possible violation of the breaking rule at the start. After reviewing video the judges determined that driver Taylor complied with the breaking rule and there was no reason to place the horse.

Race 13 – Inquiry posted concerning whether or not NO. 5 WON'T LET'EM made the fair start pole. Video showed the horse inside the pole prior to the remainder of the field being released by the starter. No. 5 WON'T LET'EM declared a starter for wagering purposes.
