


### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 1** - No. 4 KLOOROX QUEEN was first time Lasix. Announcements made via track announcer and TV scroll. Marcus Miller, driver of No. 7 TELL ME PLEASE, warned about failing to set and maintain a proper pace during the second quarter of the race.

**Race 2** - No. 4 FOX VALLEY BRUIN broke a hobble before the half and did not finish. No. 1 CLASSIFIED MATERIAL held 90 minutes postrace for blood gas testing.

**Race 12** - Recall charged to No. 3 HAVEN LANE ACE for refusing the gate. Inquiry posted (second attempt at a start) concerning whether No. 3 HAVEN LANE ACE made the fair start pole. Replay showed that the horse had not crossed past the pole prior to the rest of the field being released by the starter. No. 3 HAVEN LANE ACE declared a non-starter for wagering purposes. Refunds issued on all wagers involving the horse.
