ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 7 – Track downgraded from “fast” to “good” after a brief, but heavy rain shower.

The test barn reported possible welts on No. 5 MISTER MATT (Atlee Bender). This was confirmed by the ISA representative and an IHRC investigator.

Race 10 – Recall charged to No. 5 LUXRY VIRGIN for interference to No. 4 CHECKERS LEGACY while on a break before the start.

Inquiry posted on unofficial second place finisher No. 2 CAPTAIN MAJESTIC (Marcus Miller) for possible interference to unofficial fourth place finisher No. 4 CHECKERS LEGACY (Jordan Ross) and unofficial sixth place finisher No. 3 DONE IN SEVEN (John De Long) in late stretch nearing the finish. Video and drivers DeLong and Ross confirmed that No. 2 did not have enough room and forced his way off the rail causing interference to both horses. For interference No. 2 CAPTAIN MAJESTIC finished second placed sixth. Driver Marcus Miller fined \$200.00 for interference causing a placing.


Separate inquiry posted on unofficial third place finisher No. 8 AIRBORNE SPARK (Marvin Luna) for possible pylon violation in the last turn before ¾. After reviewing video, the judges determined that driver Luna went inside pylons to avoid a breaking horse and did not gain any advantage in so doing. Horse placed as finished then placed second after the placing of No. 2 CAPTAIN MAJESTIC.



Race 11 – Inquiry posted on unofficial fourth place finisher No. 5 VALEDICTORIAN (Don Eash) for possible violation of the breaking rule nearing the finish. Video confirmed that No. 5 VALDICTORIAN made a break before the finish and was lapped on by one other horse at the wire. For a lapped on break No. 5 VALEDICTORIAN finished fourth placed fifth.

Race 13 – No. 6 PRINCESS ARCH (Atlee Bender) originally finished seventh placed eighth for violation of the breaking rule in the stretch.
