## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - No. I POPPLETON (Kiwon Waldron) finished seventh placed tenth for violation of the breaking rule (extended break).

Race 3 - No. 4 TELLUSASURPRIZE pulled up past the quarter with a broken hobble.

Race 9 - Recall charged to No. 4 PREMIER FINE WINE (Joey Putnam) for refusing the gate.

Inquiry posted on unofficial second place finisher No. 3 ROLL-ON MIDNITE (Atlee Bender) for possible pylon violation after 3/4/s entering the top of the stretch. Video confirmed that Mr. Bender was inside two pylons and struck a third. The judges determined that this did not give the horse an unfair advantage and the horse was not lapped on by other horses. No reason for placing, but Mr. Bender fined \$100.00 for the pylon violation.
