### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 6** – Inquiry posted on unofficial second place finisher No. 2 FRUIT SNACKER (Joey Putnam) for possible interference in the far turn to unofficial sixth place finisher No. 3 TRUMP THE WARRIOR (Jordan Ross) after striking a pylon, and knocking it onto the track. After reviewing video of that incident the judges determined that No. 3 TRUMP THE WARRIOR made a break on his own and was not affected by the pylon.


Second inquiry posted on No. 2 FRUIT SNACKER for possible violation of the breaking rule in deep stretch through the finish. Video showed that the horse was lapped on at the finish by one horse, however the judges also determined that the horse failed to lose ground while off stride. No. 2 FRUIT SNACKER finished second placed fifth for violation of the breaking rule; failure to lose ground while on a break.


**Race 10** – Inquiry posted on unofficial race winner No. 2 ROCKIN MUDSLINGER (Jordan Ross) for possible pylon violation in the stretch. Video showed that the horse was inside one pylon in the stretch and the judges determined that while inside the pylon the horse passed horses gaining an unfair advantage. For a pylon violation No. 2 ROCKIN MUDSLINGER finished first placed fourth. Driver Jordan Ross fined \$200.00 for a pylon violation causing a placing.
