ADMINISTRATIVE ACTIONS, NOTES, COMMENTS



Video clearly showed No. 6 STARLIT MILLERTIME strike the outside wheel of the No. 4 causing a flat tire. For interference (striking a wheel) No. 6 STARLIT MILLERTIME finished third placed sixth. Driver Aaron Stutzman fined \$200.00 for interference.




