



### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 7** – Inquiry posted on unofficial fourth place finisher No. 6 NINER FROMDA DINER (Jared Finn) for possible violation of the breaking rule after the half. After reviewing video the judges determined that while off stride the horse interfered with unofficial race winner No. 3 FLIRTNWITHTHEPILOT. However, No. 3 beat No. 6 so there was no reason for placing for interference while on a break. The judges also determined that driver Finn complied with the breaking rule. Horse placed as originally finished.
