Race 2 - Kiwon Waldron, driver of No. 5 SIMSAM (Kiwon Waldron), fined \$100.00 for failure to set and maintain a proper pace during the second quarter.

Race 7 – Inquiry posted on unofficial second place finisher No. 4 LEVITATING (Jordan Ross) for possible interference to unofficial sixth place finisher No. 6 ROCKINATTHERYMAN (John DeLong) for possible interference in the stretch. After reviewing video and speaking with Mr. DeLong the judges determined that No. 4 LEVITATING did not have sufficient clearance to change course in the stretch and in so doing did cause interference to No. 6 ROCKINATTHERYMAN. No. 4 LEVITATING finished second placed sixth. Driver Ross fined \$200.00 for interference causing a placing.
