### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 1** - No. 3 SHADY LADY LANA charted with an equipment break before the quarter and eventually pulled up with a broken hobble. The horse will not have to qualify due to the broken equipment.

**Race 3** - Inquiry posted on unofficial race winner No. 4 ROLLIN GIANNIS (Walter Haynes, Jr.) for possible violation of the breaking rule in late stretch through the finish. The horse was lapped on by one horse at the wire, however, the judges determined that No. 4 ROLLIN GIANNIS also failed to continuously lose ground while on a break in violation of the IHRC breaking rule. No. 4 ROLLIN GIANNIS originally finished first placed fifth.

**Race 4** - Jeff Dever, driver of No. 6 SHAKEITLIKEITIS, fined \$100.00 for coming to the gate out of position and causing a recall.

**Race 8** - Inquiry posted on unofficial fourth place finisher No. 8 STEPPINOUTTOHELP (Robert Taylor) for possible violation of the breaking rule after the quarter. After reviewing video the judges determined that Mr. Taylor complied with all aspects of the breaking rule and there was no reason for placing.

**Race 9** - Inquiry posted on unofficial third place finisher No. 8 WHEELIN CLEATUS (Kevin Lambright) for possible violation of the breaking rule after the quarter. After reviewing video the judges determined that Mr. Lambright complied with all aspects of the breaking rule and there was no reason for placing.

Second inquiry posted on unofficial race winner No. 4 MR BEAR (Marcus Miller) for possible interference to unofficial fourth place finisher No. 7 BEACH PIRATE in the far turn after 3/4s. After reviewing video the judges determined that No. 4 MR BEAR was out in time and therefore did not cause interference to No. 7 BEACH PIRATE. Horses placed as finished.

**Race 10** - Delay of approximately 30 minutes due to lightning in the area.
