### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**\*\* First race delayed approximately 70 minutes due to severe thunderstorms in the area. \*\***

**Race 2** – Inquiry posted on unofficial fourth place finisher No. 3 YEAROFFEAR (Doug Rideout) for possible violation of the breaking rule before 3/4s. After watching video the judges determined that the horse was interfered with by a breaking horse and therefore no violation of the breaking rule occurred.

**Race 3** – Inquiry posted on unofficial third place finisher No. 2 BRAVO ALPHA (Doug Rideout) for possible violation of the breaking rule after the start. After reviewing video the judges determined that driver Rideout complied with the rule.

**Race 6** – Jared Seekman, driver of No. 10 DRINKSWITHTHECAPTN warned about his overzealous use of the whip.

**Race 8** – Separate inquiries posted on unofficial second place finisher No. 8 DO'S N DON'TS (Doug Rideout) and unofficial fourth place finisher No. 2 HELPTHENEEDY (Robert Taylor) for possible violations of the breaking rule before the start (No. 8) and in the far turn before and after 3/4s and in the stretch (No. 2). After reviewing video the judges determined that driver Rideout complied with the breaking and the horse was placed as finished. While the judges determined that driver Taylor






complied with the breaking rule, the horse was still of stride for more than 25 strides which per Indiana Horse Racing Commission rules constitutes an extended break. No. 2 HELP THE NEEDY finished fourth placed fifth. No. 1 SKYWAY PACQUIAO (Don Eash) originally finished sixth placed fifth placed fourth after the original fifth place finisher, No. 5 TUGGIN THOMAS (Daryl Bontrager) was placed sixth for an extended break before and after the ½.


No. 7 CLEAR THE STAGE was a late judges' scratch after trainer Ben Schwartz failed to equip his horse with trotting hobbles and did not have a set. Trainer Ben Schwartz fined \$200.00 for failure to have his horse properly equipped causing a scratch.

**Race 11** – No. 5 SAYITSNOTTRUE originally finished sixth placed seventh for interference going up the backstretch past the quarter. Odell Cross fined \$200.00 for hooking wheels with No. 8 TELL BLUE PHOTO.

Michael Detweiler, driver of No. 2 KATIE COTTON, warned about using too much arm action while whipping in the stretch.
