**Race 7** - No. 6 O SO STRAIT was first time Lasix. Announcements made via TV scroll and track announcer.



**Race 12** - Inquiry posted on unofficial second place finisher No. 7 PONDA STARBUSTED (Kyle Wilfong) for possible violation of the breaking rule in the first turn approaching the quarter. After reviewing video the judges determined that Mr. Wilfong complied with all aspects of the breaking rule. Horse placed as finished.  
Logan Loney, driver of No. 9 DON'T KEEP SECRETS, warned about using too much arm action while whipping in the stretch.

**Race 13**- General inquiry posted regarding whether No. 8 I'M A DEVIL TOO made the fair start pole after breaking behind the gate. Replay confirmed that the horse was outside of the fair start pole when the rest of the field was released by the starter. Because No. 8 I'M A DEVIL TOO failed to make the fair start pole, per IHRC, rules the horse was declared a non-starter for wagering purposes. All wagers involving No. 8 I'M A DEVIL TOO were refunded.
