
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 - No. 5 HONOROLL was a late vet scratch due to sickness after having a reaction to something while in the paddock. Per IHRC rules, superfecta wagering was cancelled.

Race 11 - With the scratch of No. 6 FOX VALLEY KODIAK, the field was reduced to five betting interests. Per IHRC wagering rules, superfecta wagering on the race was cancelled.

Race 12 - No. 2 LINSANITY did not race with Lasix as originally programmed.
