Race 7 - Brandon Bates, driver of No. 4 STAR COMMANDER N, warned that his whipping is borderline.

Race 9 – General inquiry looking into an incident before ¾. Video shows that No. 2 PERFECT PROMISES (Atlee Bender) made a break and caused interference to trailing horses while off stride. No. 2 PERFERCT PROMISES finished fifth placed eighth for interference to trailing horses while on a break.
