ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - General inquiry posted for an incident before the start of the race focusing on No. 8 PACKEDWITH LUCK. Video showed that the horse had a broken hobble then made a break. No. 8 PACKEDWITHLUCK charted with an equipment break and declared a non-starter for wagering purposes. Refunds issued on any bets involving No. 8 PACKEDWITHLUCK.

Race 10 – No. 6 ELEGANT A was a late vet scratch due to sickness after tying-up. This reduced the field to five betting interests and per IHRC rules superfecta wagering on the race was cancelled and refunded.

Race 11 – No. 2 ALWAYS B RICKI (Brad Ferguson) originally finished seventh placed eighth for going inside pylons and gaining an unfair advantage by passing a horse in the stretch.

Race 12 – General inquiry posted looking at an incident that occurred just past the half. After speaking with multiple drivers the judges determined the incident started when No. 6 LAKE VIEW CHARM (James Yoder) ran up on the horse in front of him causing the horses sitting behind him to jam up and a couple to make breaks. No. 6 LAKE VIEW CHARM originally finished

sixth placed ninth for causing interference to trailing horses.
