


**Race 2-** Approximate delay of 10 minutes due to the main starting gate malfunctioning (not the first time it has happened this meet).


**Race 9** - John DeLong, driver of No. 5 BLUEBIRD PINNACLE, fined \$200.00 for whipping after the finish.
