ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 7 - No. 3 STRAIGHT UP RYE (Jordan Ross) broke a hobble entering the first turn going to the quarter and did not finish.

Race 9 – Inquiry posted on unofficial third place finisher No. 4 ULTIMATE FANTASY (Kyle Wilfong) for possible violation of the breaking rule in the early stages of the race (after the start and before the quarter). Video confirmed that the horse gained ground while on a break and was also off stride for more than 25 strides. For violation of the breaking rule (failure to continuously lose ground and extended break) No. 4 ULTIMATE FANTASY finished third placed seventh.
