After reviewing video the judges determined that No. 6 EZ SPREE was off stride briefly, but while off stride did cause the No. 2 to change course in the stretch. For interference while on a break No. 6 EZ SPREE finished fifth placed sixth. No penalty to driver Bates.
No. 9 PLAY ME ROCK (Jordan Ross) originally finished ninth placed tenth for a lapped on break.
