Race 3 – Inquiry posted on unofficial third place finisher No. 5 BOOK THE FIGHT (Marvin Luna) for possible pylon violation in the stretch. Video showed that the horse was clearly inside two consecutive pylons and also lapped on by one other horse at the finish. For a pylon violation No. 5 BOOK THE FIGHT finished third placed fourth. Driver Luna fined \$200.00 for a pylon violation causing a placing.

Race 13 – Mike Micallef, trainer of No. 8 ST LADS CRIMINAL, fined \$100.00 for failure to have his horse properly equipped. Mr. Micallef's second trainer was nowhere to be found. Trainer Walter Haynes, Jr. harnessed the horse and trainer Tim Clevenger took care of the horse after the race. His second trainer did eventually appear after falling asleep in a restroom.
