### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 3** - General inquiry posted looking at an incident between No. 1 WHOLE LOTTA LUCK (Brad Ferguson) and No. 4 DRY CREEK REGAL (Jordan Ross) at the top of the stretch. After reviewing video the judges determined that Mr. Ferguson was at fault by drifting out into the path of No. 4 DRY CREEK REGAL causing their wheels to get hooked. No. 1 WHOLE LOTTA LUCK finished eighth placed ninth. Brad Ferguson fined \$200.00 for causing interference. No. 3 STRAIGHT BET BARBIE charted with an interference break. No. 4 DRY CREEK REGAL, No. 6 MOMENTSTRUTH, No. 7 TELL ME PLEASE, No. 8 BOUJEEFUL, and No. 9 MADDIE'S JET LADY charted with "I"s. No. 1 WHOLE LOTTA LUCK charted with a "dx" for driver caused break.

**Race 4** - General inquiry posted regarding whether No. 1 LUXURIOUS made the fair start pole. After reviewing video the judges determined that the horse was outside of the fair start pole when the rest of the field was released by the starter. No.1 LUXURIOUS declared a non-starter for wagering purposes. Refunds issued on any wagers involving No. 1 LUXURIOUS.

**Race 8** - Clay Scagnoli, driver of No. 6 I AM THE BEST, fined \$100.00 for being off the gate before the start.
