

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Separate inquiries posted on unofficial race winner No. 4 DOUBLE A JASPER (Trace Tetrick) for possible violation of the breaking rule. Second inquiry posted on unofficial third place finisher No. 5 MEADOWBROOK MARK (Marcus Miller) for possible interference to unofficial fourth place finisher No. 1 I C CAVIAR (John DeLong) in the stretch. The second inquiry was dealt with first and the judges determined that no interference occurred after speaking with Mr. DeLong and reviewing the video.

No. 4 DOUBLE A JASPER was off stride through the finish and lapped on by one other horse. For violation of the breaking rule No. 4 DOUBLE A JASPER finished first placed second.
