The second inquiry was dealt with first and the judges determined that no interference occurred after speaking with Mr. DeLong and reviewing the video.

No. 4 DOUBLE A JASPER was off stride through the finish and lapped on by one other horse. For violation of the breaking rule No.4 DOUBLE A JASPER finished first placed second.
