


### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 7** - Inquiry posted on unofficial third place finisher No. 4 BIG CHRISTIAN (Trace Tetrick) for possible violation of the breaking rule after the start. Mr. Tetrick complied with all aspects of the breaking rule and there was no reason for disqualification. Horse placed as finished.

**Race 9** - The test barn reported that No. 2 THE PANTHEIST A (Jordan Ross) had been welted. This was confirmed by ISA representatives. Jordan Ross fined \$300.00 for causing welts second offense.

**Race 11** - No. 6 BOWIE ROCKS scratched sick. This scratch reduced the field to five betting interests. Per IHRC wagering rules superfecta wagering on the race was cancelled. Hoosier Park opted to keep show wagering on the race.
