

Race 2 - Inquiry posted on unofficial fourth place finisher No. 7 PILOT'S LEGACY (Jordan Ross) for possible violation of the breaking rule before the start. After reviewing video, the judges determined that there was no reason to place the horse.

Race 3 - No. 8 DONYWHY was gelded. Announcements made via TV scroll and track announcer.

Race 9 – Inquiry posted on unofficial fourth place finisher No. 7 KARLEE GRACE (Cordarius Stewart) for possible pylon violation around the last turn nearing the 3/4s. After reviewing video the judges determined that Mr. Stewart's wheel was inside of three consecutive pylons and he was lapped on at the finish. Per IHRC rules the horse could have been placed last, however, the judges took into account the distance between the fourth and fifth place finishers and the remainder of the field and determined that a placing behind she was lapped on to would be the appropriate placing. Mr. Stewart fined \$200.00 for a pylon violation with placing.
