Race 1 - General inquiry posted regarding No. 1 LET EM DANCE and whether or not the horse made the fair start pole. Video confirmed the horse was inside the pole prior to the rest of the field being released by the starter. No. 1 LET EM DANCE declared a starter for wagering purposes.


Race 2 – Inquiry posted on unofficial second place finisher No. 3 IT'S MIKI'S WORLD (LeWayne Miller) for possible interference unofficial seventh place finisher No. 6 CUTTING CLASS (Marvin Luna) in the stretch. Video showed that No. 6 CUTTING CLASS made a break on his own and there was no interference that caused the horse to make a break. Horses placed as finished.

Race 6 – Recall due to ducks on the racing surface.

Race 10 – Separate inquiries posted on unofficial fourth place finisher No. 2 PONDA BUGATTI (Peter Wrenn) and unofficial second place finisher No. 9 SIESTA SANDMAN (Trace Tetrick) for possible violation of the breaking rule in the stretch. After reviewing video of both horses the judges determined that both were in compliance with the breaking rule. No reason for placing.
