ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 9 - Track downgraded from "fast" to sloppy after heavy rain moved through the area.

Race 10 - Approximate 40 minute weather delay due to the aforementioned heavy rain in the area.

Race 11 – Inquiry posted on unofficial race winner No. 4 FLAGMAN (Rick Plano) for possible interference to unofficial third place finisher No. 3 HELPFIRSTEDITION (John DeLong) and unofficial fourth place finisher No. 7 LINDY'S COYOTITIO for possible interference in the stretch. Video showed that No. 4 FLAGMAN did drift out in the stretch, however both DeLong and Taylor said they were not bothered by Plano's drifting and that due to the rain and mud visibility was poor. The judges concurred with their opinions and left the original finish unchanged.
