





Race 2 – General inquiry posted looking at an incident in the far turn. Unofficial fifth place finisher, No. 5 VP ROCKIN (Kyle Wilfong) was inside multiple pylons in the last turn before ¾. Mr. Wilfong stated that he was getting pressure from his stablemate unofficial third place finisher No. 3 NICK'S MONSTER (Trace Tetric) and was just being cautious. The judges did not feel there was enough interference to place No. 3 NICK'S MONSTER. However, No. 5 VP ROCKIN placed from fifth to seventh for the pylon violation.
