ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3- Inquiry posted on unofficial third place finisher No. 3 JOHNNY BROAD (Trace Tetrick) for possible breaking rule and pylon violation after 3/4s entering the stretch. After reviewing video the judges determined that: 1. Tetrick went inside pylons for safety reasons while on a break. 2. While inside pylons Tetrick did not gain an unfair advantage, in fact he lost ground as required in the rule. 3. He did not reenter the track until he had sufficient clearance to do so without causing interference to other horses. With that taken into account the judges determined that Mr. Tetrick complied with the breaking rule and did not use the pylons to gain an unfair advantage. JOHNNY BROAD placed as originally finished.

Race 4 - Inquiry posted on unofficial third place finisher No. 5 CLEAR GUIDANCE for possible pylon violation in the far turn before 3/4. After reviewing video the judges determined that No. 5 CLEAR GUIDANCE was inside one pylon and struck another. This action did not give the horse an unfair advantage. No. 5 CLEAR GUIDANCE placed as finished.


Race 6 - Inquiry posted on unofficial fourth place finisher No. 8 HOMESWEETHOME (Jordan Ross) for possible violation of the breaking rule before the start. After reviewing the break the judges determined that driver Ross complied with the breaking rule and the horse was placed as finished.






Race 12 – No. 3 DON'T LOOK BACK (Marcus Miller) originally finished fifth placed eighth for violation of the breaking rule in the stretch; extended break.

Race 13- Inquiry posted on unofficial race winner No. 3 FLYING FOZZIE (Doug Rideout) for possible violation of the breaking rule after the start. After reviewing video the judges determined that driver Rideout complied with the breaking rule. Second, general inquiry posted looking into an incident in the last turn. After reviewing video the judges determined that No. 5 GLOBE GAURD driven by Aaron Stutzman ran up on No. 2 MAXXIMILLION driven by John DeLong causing No. 5 GLOBE GAURD to briefly make a break. This break in turn caused No. 6 ROYAL REBUFF (Jordan Ross) to make a break and interference to No. 8 IVORY FOR ALL (Brandon Bates). For causing interference to trailing horses No. 5 GLOBE GUARD finished sixth placed eighth. Driver Aaron Stutzman fined \$200.00 for failing to maintain proper control of his horse and causing interference to trailing horses.
