






Race 9 – Driver change on No. 7 HIDDEN TRUTH from Marvin Luna to Kyle Wilfong. This was a program error as Mr. Luna is currently serving a driving suspension.

Race 12 – General inquiry posted looking at incident before the start involving No. 8 UNDERWRITER (Kyle Wilfong) and No. 9 MOCHA MACCHIATO (Trace Tetrick). While off stride, No. 8 UNDERWRITER interfered No. 9 MOCHA MACCHIATO nearing the start. No. 9 MOCHA MACCHIATO declared a non-starter for wagering purposes.
