ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 11 – Recall due to broken equipment on No. 8 BRAYDEN VICTORIES. After the race the judges discussed the horse with starter Todd Nixon. The decision was made to put the horse on the steward's list and make the horse qualify twice because of his continued issues approaching the starting gate.

Race 12 – Two separate inquires posted on unofficial second place finisher No. 8 MONI MADNESS (Jordan Ross) and unofficial third place finisher No. 1 BROTHER JACOB (Marcus Miller) for possible pylon violations. No. 8 MONI MADNESS was inside two pylons but did not gain an unfair advantage and was not lapped on. No. 1 BROTHER JACOB was only inside one pylon however he did pass horses and gained an unfair advantage. No. 1 BROTHER JACOB finished third placed fifth. Jordan Ross fined \$100.00 for a pylon violation with no placing. Driver Marcus Miller fined \$200.00 for the pylon violation with a placing.

Race 13 - Jared Seekman, driver of No. 2 GALLANT ATTRIBUTE, fined \$200.00 for whipping with more than minimal wrist

and elbow action.
